# Interview with Willem Engel, Virus Truth, November 30, 2020.

### Highlights:

- We've always tackled all the flu viruses together as a group, except the flu that required a vaccine to be sold.
- Errangete Promagate Bilgate
- The new vaccines represent a completely
  new method, foreign mRNA triggers our own DNA to produce virus spike
  proteins. This will disrupt our natural physiological feedback loops, putting the
  body at risk of overreacting, for example with a dangerous and potentially deadly
  'cytokine storm'.
- Vaccines will be injected into the muscles, but we don't know where in the body the spike proteins will be produced, for example the liver, the bone marrow, the brain?
- Since we don't know where in the body the spike production will take place, it can be present anywhere in the body. This makes it very difficult to assess, it requires a huge study that has not been done to the degree that is needed.
- The vaccines contain adjuvants that boost the immune system, which can also cause a cytokine storm overreaction.
- One of the spike proteins produced by our cells to trigger antibody formation

ncytin-1. This protein was taken over from a retrovirus during uired to form a placenta.

Important question that remains unanswered: When we produce antibodies against the coronavirus spike proteins, will these antibodies also neutralize the syncytin-1, as this could lead to infertility?

- The women in the pilot studies were not pregnant and were required to take contraception, which means the reproductive side effects have not been studied.
- The UK has bought a huge (IT) system to keep track of the side effects when the vaccination starts. This means that the vaccination is actually an extension of the phase 3 studies. Governments and pharmaceutical companies are conducting clinical trials on an entire population when they enforce vaccination. This is a war crime under the Nuremberg Code.
- There is a tendency towards more power for large companies, in pharmacy and healthcare this is also happening in the field of data collection. In Germany (and probably elsewhere too) large amounts of data are being collected by a powerful central institute, while the former security barriers have been lowered.

# Chronological report of the interview:

All viruses were always treated together as a group, with the exception of the flu (a vaccine had to be sold). Scaring people with terrifying photos: China, Bergamo: the same kind of photos. However, the real situation: insufficient health care, contaminated luc

ht, previous vaccinations used with unknown effect. Eastern European health workers went home when corona arrived. So there was no more care, no more people were sent to hospitals, 80 year old people in care systems, etc., this was their death, with fans even more.

The source of the change was a report from a Finnish man, ECDC researched methods such as lockdown, masks, etc. This research started late last year, people are very close to those who are selling us the pandemic.

We identified the PCR test as a major scam, now a 2nd major scam has been identified: the vaccine.

Completely new method. Swine Flu: Vaccines that are normally produced by breeding in eggs, but have been produced in bioreactors since the swine flu. Vaccines were also diluted, for example, taking only 1/10 and adding additives (adjuvants). Several adjuvants have been added to the new mRNA vaccine to boost the immune system. Immune cell signal: communicate with white blood cells. Stress, cortisol : communication between cells declines, IS weakens. Boosters trigger it: IS overreacts with cytokine storm. (9.15 ') Can be very dangerous.

Another risk can arise in people who are somewhat immune, meaning that they have an insufficient antigen concentration. If the infected antigen attacks the virus, it is already on the virus upon entering the cell. The cell is alarmed, it can also trigger harmful reactions (cytokine storm). Something like this may have happened in Bergamo: less specific antibodies; antibodies against non-corona viruses. A flu vaccine in young people can also trigger a reaction with Covid19. Can we compare it?

This needs to be investigated: We could easily find out if severe Covid19 cases had previous flu vaccinations, hospitals and insurance companies have these data.

The molecules of the new vaccines: mRNA based: via genes to protein; but they are also an epi-genetic switch. Why did they choose this path?

Our body knows what is happening and has feedback loops to regulate physiological processes. But now that external mRNA gives a command to "produce proteins," because this is not activated by the body itself, it can disrupt natural feedback loops.

The product is injected into the muscles, but where is protein production triggered. Where in our body will the mRNA go and where will it trigger responses? This is unknown. This also makes it difficult to identify side effects as we don't know where to look. It can happen in the marrow bone, in the liver, in the brain, etc.

The cells will produce spike proteins encoded by the mRNA cells and secrete the spikes. The body will respond with an alarm condition. This will trigger an immune response against these spike proteins. This can also cause a wrong regulation of the immune response (incomprehensible: 17 '? MDE ??). The second risk is unknown, so a big question: We are mammals, women produce a placenta. The placenta requires a protein, syncytin-1. This stems from a retrovirus in the past. This allows us not to lay eggs, but we can develop the egg in our body, in the

Knock-out mice, knock-out syncytin-1: infertile, failed to develop placenta. The shape of the protein is very similar to the spike protein. The spike protein is very similar to the syncytin-1 protein.

Important question: When we produce antibodies against the coronavirus spikes, will these antibodies also neutralize the syncytin-1? If this happens, syncytin-1 will not be produced. This can result in female infertility. The vaccine is prohibited for pregnant women, in the studies they had to continue with contraception for 28 days, 3 months, etc. to make sure that the women were not pregnant. With the other vaccines, there were also male fertility concerns, so there's something going on with the reproductive system. With current studies, the effects on the reproductive system will not be visible. It will be impossible to judge whether the new vaccines cause infertility.

So we will not know whether the 'vaccine' will affect syncytin-1 regulation.

The UK has bought a huge system to track down all expected side effects. This appears to be a comprehensive phase 3 study applied to the population. This is illegal and could even be a war crime, breaking the Nuremberg Code. Wodarg agrees. The drug companies call this extended follow-up studies or something, but it just means they don't know those effects and they don't want to know. They force people to vaccinate, millions, whatever is not allowed. You cannot force people to get vaccinated.

This is actually a clinical study conducted on an entire population. And the risk doesn't even lie with the pharmaceutical companies.

The same was true for the Mexican flu, where liability went to the authorities and large compensations followed. Now the same thing is happening on a much larger scale, so governments may even go bankrupt because of liability.

Argentina has already started using the Pfizer vaccine on the military. This may not be voluntary, the military hierarchy will enforce vaccination, not voluntary. Resemblance to the Spanish flu? Hard to say because so many factors were at play there.

With the corona vaccine, we know that some companies are enforcing vaccinations. Some companies force their employees to take the vaccine or else they will be disadvantaged or even fired in some way.

This is also used in studies, often abused, for example with prisoners who did not

rmed. The race to do business is now underway with 200

companies. Sponsored studies have twice as many positive results as publicly paid studies. Positive and negative reports in the media have a direct impact on profits.

The Philippines wants to start vaccinating young children aged 1-4. Is there a good reason for that? No medical reason. Children normally recover easily from Covid, so there is no good reason why one would want to start vaccinating young children with a new, potentially dangerous, under-researched drug. This is experimenting on children, this is reminiscent of Mengele. The Nuremberg Code was created by what Mengele did in World War II.

In NL, a motion has been passed in parliament that does not allow direct or indirect forced vaccination.

# What about ID and data collection?

In NL, an electronic addendum to our passports was adopted on 6 March, even before the pandemic.

Does Germany want to make this mandatory immediately? Companies collect a large harvest of data. A fellow MP ran a lobby company and proposed several laws that allow for data collection. He broke all the safety barriers doctors have. A doctor who had strong barriers, double barriers, was immediately punished. Now they have to release all the data or they will not be paid by the insurance companies. Former pharmacy chief now heads the institute responsible for all data collection in Germany. He works with big techies like Apple etc., the governments don't realize this. This gives tremendous power to these institutions. When they have all the data, they can figure out how to pressure people. Big data is a big problem. This has also been discussed with Scott Jensen, the crisis of responsibility. Responsibilities are taken from individuals to pharma / companies.

Indeed for 30 years. Even with household waste, which is also a big monopoly, only 5 companies in Europe cover waste treatment for all of Europe. Monopolies with other large companies, such as energy / electricity producers. The same goes for all the goods we buy, the same goes for mobility. Big corporations have monopolies, they are profit centers but communicate that they do all this for us.

### 2030 Agenda is misusing Covid to advance other political agendas.

Wodarg's message to NL: you should be afraid, but not of the virus. Living together is sometimes a bit dangerous, but we can handle that with our immune system. Be afraid of the government and their big plans.
